This is a program led by the Duluth Community School Collaborative in partnership with Myers Wilkins Elementary School.

In addition to offering afternoon activities, staff also provide support to the Myers Wilkins Excel Program classrooms during the weeks of July 12–28. This provides integrated student supports and expanded & enriched learning time and opportunities as a full-service community school.

Den coordinators are Myers Wilkins staff during the school year and are hired by DCSC for this program.

The Integration Specialists are employed by ISD709 during the school year at the middle schools, and are still employed by the district this summer on special assignment with us.

The Americorps members are through DCSC.

The Myers-Wilkins Community School Wolf Den Summer Program is dedicated to reinforcing pre-established routines within the school community. Throughout the school year, students can earn a Positive Paw for demonstrating Myers-Wilkins core values: Be Respectful, Be Responsible, and Be Safe.





Students observed demonstrating the core values in our program will be awarded a positive paw. These paws may be entered in a drawing or counted towards a larger goal for a whole group celebration!







We are committed to creating a safe, welcoming, and positive environment for all students in our program. We take preventative measures such as pre-teaching and rewarding behaviors we want to see.



Students will reflect with staff when they exhibit behaviors that do not live up to the values of our school community. We will document these reflections and include you in co-creating strategies to restore the harm and prevent the behavior in the future. We will do our best to help every student participate successfully, but in the case that we have exhausted our resources and the student is still not able to participate safely on a daily basis, we withhold the right to suspend or terminate students from





program.

COVID Guidelines & Reporting Absences

Our COVID policy is the same as the District EXCEL Summer School Program.

Families are asked to check temperatures and conduct home symptom screening before sending children to the program. Keep children home if they have a fever or symptoms.

Masks are required for all students, staff, and guardians while in the building. Duluth Public Schools policy all students older than 5 years of age and staff will be required to wear cloth face coverings, (unless medically exempt). Only students with documented medical conditions and/or IEP team determined cognitive or behavioral health concerns will be allowed to not wear a mask. School water fountains are not available at this time.

Lunches will be served seated, in classrooms, at sanitized tables, and students will be required to wash or sanitize hands before & after eating.
